A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ARVIN ESTABLISHING FEES FOR ANIMAL CONTROL SERVICES, LICENSING AND REGULATION.

WHEREAS, California Government Code section 36935 *et seq.* allows fees to be established and set by resolution of the City Council; and

WHEREAS the City Council of the City of Arvin adopted Ordinance No. 380 on March 24, 2009, providing for the establishment of fees for animal control, licensing and regulation by resolution; and

WHEREAS, the City Council and staff have conducted an analysis of the fees associated with regulating animals and find that the fees are reasonably related to the services provided, and do not to exceed the value of the services provided; and

WHEREAS, the City Council finds it in the best interest of the health, safety and welfare of the residents of the City of Arvin to authorize the City Council to establish fees for animal regulations by resolution as further described in Exhibit A;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ARVIN DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. <u>Recitals</u>. The Arvin City Council finds and declares that the above recitals are true and correct and incorporates them herein.

SECTION 2. <u>Effective Date</u>. This Resolution and its Exhibit A: Fee Schedule shall take effect from and after its date of passage, approval and adoption.

SECTION 3. <u>Certification</u>. The City Clerk shall certify the adoption of this Resolution.
