**NOTICE IS HEREBY GIVEN** that the City of Arvin, County of Kern, California, will receive up to, but not later than the time set forth above, sealed contract bids for the award of a contract for **SYCAMORE ROAD STORM DRAINAGE IMPROVEMENT PROJECT**. All bids shall be made on the form furnished by the City and shall be opened and publicly read aloud at the above-stated time at the place of bid receipt identified above.

Sealed bids must be placed in a sealed package with the word "Bids," the project name and identification number typed or clearly printed on the lower left corner of the package.

**PROJECT IDENTIFICATION AND NAME:**  
**SYCAMORE ROAD STORM DRAINAGE IMPROVEMENT PROJECT**

**DESCRIPTION OF WORK:**

The primary work items are generally described as follows:

1. Construct storm drain pipeline along Comanche Drive, Sycamore Road, and Meyer Street, including manholes, inlets, connections with existing storm drains, control structures, and trench resurfacing.
2. Excavation of a new retention basin on Comanche Drive, south of El Camino Real. Stockpiling of excavated soil at approved site. Construct outlet structure, dry wells, fencing, and remove existing landowner irrigation facilities and install new irrigation facilities.
3. Reconstruct northern portion of Meyer Street and Sycamore Road intersection including the removal of the existing valley gutter, pavement, curb and gutter, and handicap ramp; grading of existing street, constructing AC pavement section, and constructing new ADA ramp.

**COMPENSATION:** Payments shall be in the amounts listed on the Bid Sheet as awarded by the City.

**PRE-BID MEETING:** A non-mandatory pre-bid meeting has been scheduled for 9:00 a.m. on Tuesday, August 23, 2016, at the address listed above, as noted in the Instructions to Bidders.

**OBTAINING BID DOCUMENTS:** Contract documents for the above referenced project may be obtained at the Office of the City Clerk, City Hall, Arvin, upon payment of \$30.00 for each set. The Contractor shall purchase a bid set from the City Clerk in order to bid on the project. This amount is not refundable.
